PARISH VEGETATION/HEDGE CUTTING UPDATE: As reported at May's meeting, vegetation is no longer overhanging the road on Otham Street.
Clerk to enquire what maintenance has been agreed for the Bicknor Wood hedge and when this will be carried out?

VILLAGE HALL REQUEST TO CONSIDER MANAGEMENT: Response from Ms Purvis is awaited in respect of what help is available in the community?

The PC was advised that the grant time frame for the replacement windows has been exceeded and the grant will have to be returned.

Alternative options to be considered for use as a VH: Senacre Community Centre, White Horse PH and the Football Club.

- **CIL PROJECTS:** Original suggestions recirculated for the benefit of new members and individually reviewed. Timing is not considered correct to move forward with some items.
 - Cricket Club Cllr Newton to ask if the club is still active and if a fence is still required?
 If a grant is agreed, match funding would be required from the club.

ACTION: Cllr Newton

Footpath that runs from White Horse Lane to Sutton Road is due for an upgrade.
 PC to determine how much of the PROW will be upgraded by KCC/the developer and determine if any further work will be required?

 Farmer/Kirkwood Trust to be asked if they will consider a Type 1 footpath, or similar, through the middle of the field opposite the church, to produce an all-weather surface.

- New notice boards. Developer has agreed to fund new boards for their sites. Consideration to be given if further boards required in the parish?
- Purchase of The Glebe/acquiring land was agreed as a good idea.
- Bicknor Woods Community Group has indicated that they will be requesting a further grant towards kissing gates.
- Cllr Gray to check land registry for ownership of areas discussed and provide an update.
 ACTION: Cllr Gray
- Request to be made to Kirkwood Trust to ask if they would consider selling a strip of woodland from Bicknor Wood to Parsonage Place to provide a safe pedestrian/cycle route.

 ACTION: Resident*
- 17 OPC BANNER: It was RESOLVED that an upright OPC banner be purchased as a replacement for the missing banner.
